b. Feasibility Master Plan

A Shelburn resident asked about the time limit for lease. Jordan explained how all branches are library-owned except for Shelburn. Aaron said we are looking at options.

Betty Dunford asked about Carlisle building and how it was paid for.

Tracey Drappo thanked the Board and presented student letters in support of Shelburn library.

Jennifer Strahle said her students walk to the Hymera library and asked what is going to happen to her kids. She asks for something or anything for the Hymera library. Chris and Terri explained that these choices are difficult.

A Hymera resident was at the meeting last December. The Board in the past decided not to take Hymera into the system. Currently, they pay no rent and the town pays for the water. Susan asks if they are receiving a grant.

Jordan Stowers thanked the Board for hearing from residents. She was wondering about Shelburn issues and asked for a quick summary of the issues. Jordan explained the coverage map.
